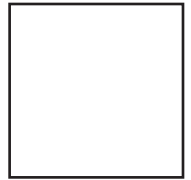

# Please Read—Action Required.

Nintendo is pleased to announce changes to the investment options available through the Nintendo 401(k) Savings Plan (the "Plan") as part of the transition to Schwab Retirement Plan Services, Inc. on **February 1, 2019**.

**Investment election window: January 14, 2019, through January 24, 2019 at 1 p.m. PT.**

Read through this communication to learn about what actions you are able to take during the investment election period.

**Please note: If no action is taken, Choice 1 will apply.**



## Choice 1:

Reinvest your investment elections for current and future contributions into an age-based target retirement portfolio from Morningstar Investment Management LLC.<sup>1</sup>

You can choose to invest in the target retirement portfolios from Morningstar Investment Management. The portfolios automatically diversify contributions and rebalance your account based on the year you want to retire and your risk preference. As you approach retirement, your portfolio gradually shifts focus from more aggressive to more conservative.



## Choice 2:

Keep your investment elections the same.

You can keep your investment elections for current and future contributions the same as they exist at Transamerica as of January 24, 2019 (when the blackout begins).



## Investment election window.

The election window for the new investment options will begin on **Monday, January 14, 2019 at 4 a.m. PT**, at which time you may make the selections based on the two choices to direct your investments. Any new contributions received after you have made your election will also be directed to your new investment elections.

If you have not made your new investment election on or before **Thursday, January 24, 2019 by 1 p.m. PT**, any new contributions received will be directed to the target retirement portfolio from Morningstar Investment Management that corresponds with your date of birth.

If you do not take action during the investment election window, you may access your Plan account to make changes following the completion of the transition.

## Take action!

To log in to your account, go to [workplace.schwab.com/nintendo](https://workplace.schwab.com/nintendo), click **New User** then **Register Now** to access your Plan account for the first time. After logging in, you will see two buttons:

**Choice 1: Transfer investment elections to age-based target retirement portfolio**—"I would like my current and future investments to be allocated to a target retirement portfolio from Morningstar Investment Management based on my date of birth." These target retirement portfolios are created by Morningstar Investment Management from the core fund lineup in the Plan.

**Choice 2: Opt out and keep investment elections the same**—"I would like to keep my investments the same as they were at Transamerica." To view your current investments, log in to your account at Transamerica.

Please note that your deferral percentage rate(s) on file at Transamerica immediately prior to the blackout will transfer to your Plan account at Schwab Retirement Plan Services, Inc. You may make changes to your deferral percentage rate(s) and investment elections at any time following the completion of the transition.
